PROGRAM:

Chief John Miller introduced Tom Winkler [Hurst Tool Specialist] with MES who provided a very informative update on the NFPA Standard 1937 Rescue Power Tools and the expected changes forthcoming in the 2020 edition. A snapshot of the presentation as follows:

- 1. Rescue Tool History Prior to 2010 NFPA did not address rescue tools and there were no standards
- 2. 2015 NFPA 1936
 - No accessories covered nor was user safety addressed
 - Tools not required to comply
 - Cutters covered by third-party testing
 - Cutters and Spreaders performance rated by NFPA
 - Old tools do not cut new car metals [new standard and tool design based on new metals]
- 2020 New Standard Edition
 - Test Charts will expand
 - Expiration date on tools
 - Tool mounting will be addressed and amount of equipment
 - Struts and Bags not currently covered but may be addressed in new standard
 - Performance standards hydro-static tests
